Diane M. Beck is a Full Professor in the Department of Psychology and directs the Attention & Perception Lab at the University of Illinois. She is a member of the Neuroscience Program and the Group Leader of Biologically-Informed AI at the Beckman Institute for Advanced Science and Technology, at the University of Illinois. She received her Ph.D. from the University of California, Berkeley, and was a postdoctoral fellow at University College London and at Princeton University. She uses behavioural methods, functional magnetic resonance imaging (fMRI), transcranial magnetic stimulation (TMS), electroencephalography (EEG) and optical imaging to understand the neural processes that enable and limit our visual understanding.

Dr. Berland is broadly interested in facilitating and studying students as they engage in sensemaking practices (with a focus on K-12 students sensemaking about scientific phenomena, teacher candidates sensemaking about pedagogical phenomena, and educators making sense of their shared antiracist vision and goals). In this work, she uses sociocultural lenses to argue that engagement in sensemaking requires that learning activities be experienced by the learners as working towards a sensemaking goal, rather than as a set of disconnected procedures that satisfy an evaluative audience (i.e., a teacher, a principal, etc.).

Anke Birkenmaier is currently serving as chair of the Spanish and Portuguese department in the College of Arts and Sciences at Indiana University. Birkenmaier is a scholar of modern Caribbean and Latin American literature and culture, and in studying these areas she has two major foci. She studies literature in relation to other discourses such as anthropology, looking at the ways in which ideas about culture and race have evolved over time. Her interest in media and sound studies has also led her to explore the ways in which the novel has entered in competition with other communication media. Her award-winning book, Alejo Carpentier y la cultura del surrealismo en América Latina (2006) presented an analysis of the early years of Cuban writer Alejo Carpentier, when he engaged with "dissident" surrealists in Paris in the 1930s and worked for the radio and advertising industry.
